Macquarie Primary School is excited to be offering Year 2 and 3 students the opportunity to acquire essential life skills in water safety and survival through Royal Life Saving ACT.

The ACT Education Directorate provides funding for Year 2 students in ACT Public Schools to participate in the Royal Life Saving ACT *Aqua Safe* program focused on general water safety and personal aquatic survival skills. This year our year 3 students are also being offered this program due to its cancellation in 2020 during Covid-19. This targeted approach will ensure every participating student has the opportunity to access structured aquatic activities during primary school. These lessons will run for 1 hour per day for one week. Our students will be participating **15-19 March** at Canberra International Sports and Aquatic Centre (CISAC).

The cost of the program is **\$50 per student** and is not due until Friday 5 March.

## Year 2 Aquasafe

Dear Families,

Aquasafe is a unique water safety and awareness program designed specifically for Year 2 students in the ACT. The concept of the program was developed as a joint initiative between Royal Life Saving ACT and the ACT Government Education Directorate. Participation for the program is partially funded by the ACT Government. This funding increases accessibility and affordability of the program for all students.

Students in year 2 participate in the Aquasafe program for 5 consecutive school days. Lessons are one hour in length.

A risk assessment has been completed and is available to view at the front office.

**When:** Monday 15 March to Friday 19 March (1 hour per day)
